Opening Prayer: Bishop Sparks began the meeting at 6:30 PM with a prayer.

Faith Community Check-In:

St. Paul:

- Positive Planning a fashion show in the Cloister in the fall as a fundraiser.

St. Timothy:

- Positive –We were able to get our hall rented, great Face book post about our church and some new possible members to our parish.
- Challenge Getting our bills paid.

- Challenge Finding old Palms to burn for the Ash Wednesday ashes.

St. Christopher:

- Positive Shrove Tuesday Pancake Supper on March 5th starting at 6 PM.
- Challenge Problems with maintenance work at our church.

- Positive –We had three new visitors to our church, celebrated Black History Month and had a very dynamic speaker at our Morning Prayer service.
- Challenge People going on vacations and a need for help getting things done.

St. Augustine:

Positive – We are having a Shrove Tuesday Pancake Supper on March 5th from 5:30 to 7 PM.
 Challenge – Working through some problems with Chase Bank due to changing personnel on our church account.

Approval of the Minutes from December 6th Meeting:

A motion was made by Ben and seconded by Pam to approve the Minutes as read. Motion carried.

Financial Report: Presented by Jessica Rieger and Greg Croyle – Co-CEMP Treasurers Bishop Doug expressed a huge appreciation for the years of service that Judy Gabrys provided CEMP since its formation. He also introduced the two new people that will serve as Co-CEMP Treasurers. Jessica and Greg then reported on the new format and information provided on the Financial Report.

- Present CEMP checking account balance is \$96,296.44
- Expenses for the last two months were \$8,397.06
- Income for the last two months were \$8,695.00
- Sabbatical Fund is \$1,875.
- Discretionary Fund is \$4,127.42
- Grant money available is \$3,020.05
- Camp Scholarship Fund is \$0
- Food Pantry Fund is \$4,576.43
- Total CEMP Assets are \$94,964.12

Discussion on our 2019 Annual Budget for CEMP was reviewed. A motion was made by Pauline and seconded by Ellen to accept the new Financial Statement provided at this meeting as our 2019 CEMP Annual Budget. Additional information was given by St. Paul's concerning a change in their monthly contributions they would provide toward the CEMP Budget. They will be reducing their contribution from \$2600 per month to \$2000 per month. This required an amended motion to be made to alter the original budget numbers for our income being received. This motion was made by Sherry and seconded by Josie to amend the original budget proposal. Motion carried. We then went back to the original motion of approving this new amended budget and the motion passed.

Jessica reported on the new procedures that will be followed in the accounts payable. All Senior Wardens will serve as new signatories on the CEMP account. They will be asked to provide signatures as needed for bills to be paid. The supply priests and CEMP Clergy will be paid twice a month and they are responsible for filling out the Authorization Form that will determination dates served and mileage occurred.

Bishop Doug encouraged us to consider an Audit of CEMP at the end of the year.

Old Business:

Housing Resolutions for 2019 for the CEMP Clergy were discussed. A portion of the allotment for housing that Pastor Kris and Pastor Pamela will want to claim as non-taxable was provided by Bishop Doug. A motion was made by Melvin and seconded by Ellen to approve the designated proposal for the Housing Resolution. Motion carried. The Senior Wardens then signed this approved proposal.

New Business:

- CEMP Clergy Update:
 - Mother Michelle continues to provide CEMP a schedule for the Clergy assigned to each parish monthly.
 - Paul Kincaid provided exceptional testimony on the outstanding contributions made by Pastor Pamela in her role in Pastoral Care from his family's personal experience.
- Lenten Study for 2019 was discussed with Bishop Sparks giving us the topics being discussed each week and the assigned leader.
